Observed chicken sandwiches at 122 degrees. Manager states chicken cooked at 189 at 9:20AM. Observed pass thru warmer at 138 degrees. Manager will make a work order and reheat the sandwiches. Advised to dispose of any leftovers after service.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
