Observed chicken sandwiches at 125 degrees. Food was placed in container instead of hot holding warmers. Sandwiches cooked at 189 degrees at 10AM. Ensure hot holding is maintained at 135 degrees.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
