Violation #21. Hot holding temperatures

Observed potato wedges at 119 degrees in pass thru warmer. Ensure PHF/TCS foods, which are held hot, must be maintained at 135°F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.

Violation #22. Cold holding temperatures

Observed coleslaw in pass thru cooler at 52 degrees. Manager states it was prepared at 10AM. Ensure PHF/TCS foods, which are held cold must be maintained at 41°F.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held cold, and not subject to an approved HACCP plan, must be maintained at 41°F.

Violation #39. No Contamination (preparation, storage, display)

Observed boxes of food on floor of dry storage area. Ensure food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.

CODE REFERENCE: 64E-11.003(2). Food shall be protected from sources of contamination and stored in a clean, dry location at least 6 inches above the floor.
