Observed burger buns in fridge in covered. All stored food products must be covered to protect from contamination.

CODE REFERENCE: 64E-11.003(2). Foods shall be stored and handled to prevent cross-contamination. Raw animal foods shall be separated from RTE food and from other raw animal food during storage, preparation, holding, and display. Single-use gloves shall be used for only one task and purpose and discarded when damage occurs or the task is interrupted.

Violation #23. Date marking and disposition

Observed tortillas in fridge outside of their original container and not date labeled. All food items outside of their original container must be date labeled. CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are RTE and held refrigerated for more than 24 hours, shall be properly date marked unless otherwise exempted.

Violation #52. Sewage & waste water properly disposed

Dumpster has a large crack in the bottom. Repair or replace dumpster.

CODE REFERENCE: 64E-11.003(5)(b). Sewage and waste water disposal shall comply with the provisions of Chapter 64E-6 or 62-600, FAC.
