Observed cooler at 33F and freezer at -7F. Serving food at time of inspection. Hot holding Chili/beans at 138F Ground beef observed at 135F. Cold holding Yogurt observed at 40F, Ice cream observed at -11. Observed food stored on the ground in dry storage. Correct by next inspection.
