Manager stated they are using the food rack distribution process at the request of the principal in anticiaption of kitchen renovations next month. Staff have been regularly placing the hot holding and colding holding foods fro the kitchen onto the food racks to minimize temperature abuse.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
