5. Students must maintain the 90% attendance rate per class period during the 2023-2024 school year.
6. Parking permits are \$50.00 per year and are non-transferrable. Replacement tags are \$10.00.
7. Application requires Parent/Guardian's approval and signatures – MUST be notarized.

1. I understand my student will not leave campus in the vehicle at any time during the school day without specific permission, signing out through the attendance office and obtaining a leave permit.
2. I understand students are prohibited from leaving the campus for lunch or taking other students off campus during school hours.
3. I understand my student will park in their assigned parking lot/student area and ensure any passengers, if applicable, are wearing seatbelts. Upon arrival to school, students are expected to exit their vehicle. (No loitering in parking lots)
4. I acknowledge parking decals are to be displayed in the front window of the vehicle so that the decal is visible from the outside and if the vehicle is improperly parked or not properly displaying a valid parking decal it may result in a discipline.
5. Students are responsible for the safe operation of their vehicles as well as the contents within their vehicles.
6. The school is not responsible for damages, theft, etc. to personal vehicles or their contents while on campus.
7. Permission for parking may be rescinded at any point in time during the school year for:
 - A. Four or more tardies to school
 - B. Five or more unexcused absences
 - C. Failure to maintain a minimum of 2.0 GPA
 - D. Excessive disciplines – ISS/OSS or any combination thereof, 3 or more times
8. Students must adhere to all School Board Policies and Florida Statutes pertaining to motor vehicles. Violations of School Board Policies and Florida Statutes will result in the revocation of the student’s hang tag and driving privileges.
9. Personal Search: Students and their vehicles may also be searched by the school principal or designee if the school official has reason to believe that the health and safety of that student or other students in the school are in jeopardy or the student is in possession of items prohibited at schools.
